Planning and Regulatory Capabilities

Planning and regulatory capabilities are the plans, policies, codes, and ordinances that prevent and reduce the impacts of hazards. Please answer whether your jurisdiction has the listed plans or programs, when they were last updated, and if the plan or program is being used or followed. For the land use planning and building codes section, please answer if your jurisdiction has the regulatory tool, when it was last updated, and if the tools are adequately administered or enforced. Under ISO Rating please provide the jurisdiction's rating for the Community Rating System (CRS) Program, Property Protection Classification (PPC), and Building Code Effectiveness Grading Schedule (BCEGS) with the rating of 1 to 10.
